# Sopapilla Cheesecake

2 cans Pillsbury butter crescent rolls (seamless, if you can find them)

2 (8oz) packages of cream cheese (softened)

1 cup sugar

1 teaspoon vanilla

½ cup butter (melted)

Cinnamon & Sugar (about ¼ cup of sugar and 1 Tbsp. of Cinnamon)

Preheat oven to 350 degrees. If using a glass pan, adjust the temperature to 325 degrees. Unroll and spread one can of crescent rolls on the bottom of ungreased 9 x 13 inch pan. If you aren't using the seamless crescents, be sure to smooth out the seam before adding the filling. Combine softened cream cheese, sugar and vanilla in a bowl. Spread mixture over crescent rolls. Unroll and spread remaining crescent rolls over mixture, being sure to press together any seams. Spread melted butter over the top and sprinkle with cinnamon and sugar. Bake for 20 to 30 minutes.
